**RESOLUTION OF THE UNION COUNTY IMPROVEMENT AUTHORITY  
DESIGNATING THE AUTHORITY'S OFFICIAL NEWSPAPERS AS THE LOCAL  
SOURCE NEWSPAPER AND THE STAR LEDGER**

WHEREAS, the Union County Improvement Authority (the "Authority") has been duly created by ordinance of the Union County Board of Chosen Freeholders as a public body corporate and politic of the State of New Jersey pursuant to and in accordance with the County Improvement Authorities Law, N.J.S.A. 40:37A-44, et seq.; and

WHEREAS, the Open Public Meeting Act, N.J.S.A., 10-4-6 et. seq., requires the Authority to designate at least two newspapers that have the greatest likelihood of informing the public of the Authority's public meetings and other official matters such as legal publications of the Authority, and require the Authority to designate such newspapers as the Authority's official newspapers; and

**NOW THEREFORE BE IT RESOVLES BY THE UNION COUNTY IMPROVEMENT AUTHORITY**, that the Local Source Newspaper and the Star Ledger shall be and are hereby designated as the official newspapers for the Authority as required by N.J.S.A. 10:4-8.d.

**AND BE IT FURTHER RESOLVED** that this resolution shall take effect immediately.
