Commissioner Rountree made a motion to approve resolution 101-2016, to rename the Park Madison Building in Plainfield, New Jersey to the Jerry Green Building. Commissioner Bornstad seconded the motion and was approved by all members resent by roll call vote.

Mr. Sullivan introduced Bakari Lee, Esq., the Authority's bond counsel to explain the details of the following resolutions all pertaining to the Roselle Mind and Body Community Center and Roselle Board of Education Early Childhood Learning Center Project. 102-2016 the issuance of County Guaranteed Lease Revenue Bonds, Series 2016 (Borough of Roselle Community Center and Library project) of the Union County Improvement Authority and determining other matters related thereto; 103-2016 Supplemental Bond Resolution authorizing the issuance of not to exceed \$34,000,000 County Guaranteed Lease Revenue Bonds, Series 2016 (Borough of Roselle Community Center and Library Project) of the Union County Improvement Authority and determining various other matters in connection therewith; 104-2016 Authorizing the issuance of County Guaranteed Lease Revenue Bonds, Series 2016 (Roselle Board of Education Early Childhood Learning Center Project) of the Union County Improvement Authority and determining other matters related thereto; 105-2016 Supplemental Bond Resolution authorizing the issuance of not to exceed \$24,000,000 County Guaranteed Lease Revenue Bonds, Series 2016 (Roselle Board of Education Early Childhood Learning Center Project) of the Union County Improvement Authority and determining various other matters in connection therewith; and 106-2016 Resolution concerning review of the findings of the Local Finance Board made at a meeting of said board on September 14, 2016 in accordance with the provisions of N.J.S.A. 40a:5a-7 with respect to the issuance of County Guaranteed Lease Revenue Bonds, Series 2016 (Roselle Board of Education Early Childhood Learning Center Project) and County Guaranteed Lease Revenue Bonds, Series 2016 (Borough of Roselle Community Center and Library Project). The motion was made by Commissioner Bornstad and seconded by Commissioner Lattimore with all members present voting in the affirmative by roll call vote.
