May 4, 2016 Regular Public Meeting

Vice Chairwoman Rountree called the meeting to order at 5:04 pm in the meeting room of the Union County Improvement Authority, 1499 US Highway One, North, Rahway, New Jersey.

Notice of Compliance of the Open Public Meetings Act was read by Clerk da Silva.

Report of Executive Director, Committees, Staff and Counsel – Public Session I a) Resolutions/Consent Agenda

Commissioners Tomko made a motion to approve resolution 39-2016, approving the Public and Executive meeting minutes of April 6, 2016. The motion was seconded by Commissioner Bornstad and approved by all members present except Chairman Scutari who abstained.

Commissioner Hockaday made a motion to approve resolution 40-2016 approving a bill list and the release of vouchers for processing and payment, subject to the certification that sufficient funds are available. The motion was seconded by Commissioner Salerno and approved by all members present.

Bakari Lee, communicated to the Board the purpose and details of the resolution. Commissioner Bornstad made a motion to approve resolution 41-2016, Authorizing the issuance of the City Guaranteed Lease Revenue Bonds, Series 2016 (City of Linden Omnibus Revenue Refunding Project) of the Union County Improvement Authority and determining other matters related thereto. The motion was seconded by Commissioner Rountree and approve by all members present by roll call vote.

Commissioner Rountree made a motion to approve resolution 42-2016, increasing the cap for CME Associates professional services agreement for services related to the procurement of capital improvements to the Union County Juvenile Detention Center. The motioned was seconded by Commissioner Hockaday and approved by all members present by roll call vote.

Ted Domuracki provided the Commissioners with a status update on the construction of the new Union County Family Courthouse. Sean Edmonds explained the details of the Change Order. Commissioner Rountree made a motion to approve resolution 43-2016, approving Change Order No. 3 to the contract for the construction of the new Union County Family Courthouse Building at Cherry Street, Elizabeth, New Jersey. The motion was seconded by Commissioner Lattimore and approved by all members present by roll call vote.

Report of Committees, Staff and Counsel - Executive Session.

The motion was seconded by Szpond and approved by all members present by roll call vote.

Commissioner Salerno made a motion to approve resolution 46-2016; approving and authorizing a sixty day extension of a Management Agreement between the Union County Improvement Authority and Nobel Property Management, LLC. The motion was seconded by Commissioner Bornstad and approved by all members present by roll call vote.
