RESOLUTION OF THE UNION COUNTY IMPROVEMENT AUTHORITY APPROVING CHANGE ORDER TO THE CONTRACT WITH MARBRIDGE ENTERPRISES, INC. FOR THE UNION COUNTY COLLEGE, CRANFORD CAMPUS STUDENT SERVICES CONSTRUCTION PROJECT

WHEREAS, the Union County Improvement Authority (the "Authority") was created by resolution of the Board of Chosen Freeholders of the County of Union as a public body corporate and politic of the State of New Jersey, pursuant to and in accordance with the County Improvement Authorities Law, N.J.S.A. 40:37A-44 et seq., and the acts amendatory thereof and supplemental thereto; and

WHEREAS, the Authority entered into a Shared Services Agreement dated September 28, 2011 with Union County Community College (the "College"), pursuant to the Uniformed Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq., in which the College requested that the Authority assist it with the design, financing, management and construction of a new two-story addition of approximately 35,000 square feet that will provide space for student services and additional classrooms at the College's Cranford Campus (the "Project"), and the Authority agreed to undertake all actions necessary to implement the Project, which included the award of a construction contract after public bidding, to Mar-Bridge Enterprises, Inc. ("Contractor"), as the lowest responsible bidder; and

WHEREAS, due to delays in the Project Schedule caused by winter conditions work stoppage resulting from mechanical piping revisions that moved concrete footing/foundation work activities into winter months, the Contractor/Construction Manager have proposed Change Order No. CM-002 revising the contract completion date to July 15, 2016 (see attached); and

WHEREAS, this change order represents an extension of time only, with no cost change to the original Contract Sum.

NOW, THEREFORE BE IT RESOLVED by the Union County Improvement Authority that Change Order No. CM-002 to the Project, in the form attached hereto and made a part hereof, be approved, and the Contract between the Authority and the Contractor be modified to reflect the revised Contract completion date of July 15, 2016; and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.

Delays incurred due to winter conditions work stoppage resulting from mechanical piping revisions (reference change order 001) that moved concrete footing/foundation work activities into winter months which caused an extension of an additional 129 calendar days to the project schedule.

The contract time will be increased by one hundred twenty nine calendar days (129). The contractor shall complete the project for owner occupancy by July 15, 2016 based on July 14, 2014 date of notice to proceed. The 528 calendar days, original contract duration, has increased to 732 total calendar days which includes the previous change order number 001 extension of 75 calendar days.
