RESOLUTION OF THE UNION COUNTY IMPROVEMENT AUTHORITY AUTHORIZING AN EXTENDED SERVICES AGREEMENT WITH NETTA ARCHITECTS IN CONNECTION WITH THE NEW UNION COUNTY FAMILY COURT BUILDING AT CHERRY STREET IN ELIZABETH, NEW JERSEY.

WHEREAS, the Authority entered into a Shared Services Agreement dated November 1, 2011 with the County of Union (the "County"), pursuant to the Uniformed Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq., in which the County requested that the Authority assist it with the design, financing, management and construction of a new Family Court Building and Parking Deck for the Superior Court, County of Union (the "Project") in Elizabeth, New Jersey, and the Authority has agreed to undertake all actions necessary to implement the Project, which include, but are not limited to, the hiring of certain professionals for the Project; and

WHEREAS, the County has previously contracted with Netta Architects ("Netta") for Architectural and Engineering Design of the Project, as described and included in Netta's proposal dated September 14, 2009, approved on January 21, 2010 by Resolution No. 2010-92 of the Board of Chosen Freeholders of the County of Union, and amended on July 9, 2010 by Resolution No. 2010-354 (the "Proposal"), and

WHEREAS, the Authority was authorized by the Shared Services Agreement and by law to contract for professional services such as those contemplated in this Agreement, without public advertising or bidding pursuant to N.J.S.A. 40A:11-1 et seq. and;

WHEREAS, On February 22, 2012, the Authority and Netta entered into a Professional Services Agreement (the "Agreement"), pursuant to Netta's services and fee proposal included therein, to provide all services concerning the Project, including, but not limited to, Architectural and Engineering Design of the Project, for and on behalf of the Authority for a cost not to exceed \$869,102.00, as set forth in the Agreement; and

WHEREAS, On February 22, 2012, the Board of Commissioners of the Authority adopted Resolution 22-2012, approving the Agreement between the Authority and Netta; and

WHEREAS, in or about January 2015, the Authority issued Requests for Qualifications through a fair and open process for various consulting and professional services and the Authority received a proposal from Netta in response to the RFQ; and

WHEREAS, after evaluation, the Authority prequalified various firms to perform consulting and professional services for the Authority on an as-needed basis; and

WHEREAS, by resolution adopted by the Authority on February 4, 2015, Netta was one of the firms prequalified to perform Professional Services; and

WHEREAS, the Authority has a need for an extension of the Agreement with Netta for Architectural and Engineering Design services in connection with the Project to redesign a portion of the second floor originally designed for the Authority's Officers, which will now be used for the Union County Prosecutor's Office; and

WHEREAS, April 18, 2016, Netta submitted a proposal to extend their Agreement for Services in connection with the Project, for an amount not to exceed \$29,300.00, a copy of which is attached hereto as Exhibit A; and

WHEREAS, the Authority has reviewed Netta's proposal and desires to extend its Agreement with Netta for an amount not to exceed \$29,300.00.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Authority as follows:

- 1. The aforesaid recitals are incorporated herein as if set forth at length;
- 2. The Authority hereby awards an extension to the Agreement for Architectural and Engineering Design of the Project with Netta, pursuant to and in accordance with its proposal (Exhibit A);
- 3. The Executive Director is hereby authorized and directed to execute the extension of the Agreement between the Authority and Netta for an amount not to exceed \$29,300.00;
- 4. The Executive Director is hereby authorized and directed to take any and all actions necessary to implement the contract;
- 5. This resolution shall be published in accordance with law.
