June 8, 2016 Regular Public Meeting

Commissioner Bornstad called the meeting to order at 5:05 pm in the meeting room of the Union County Improvement Authority, 1499 US Highway One, North, Rahway, New Jersey.

Notice of Compliance of the Open Public Meetings Act was read by Clerk da Silva.

A roll call of Commissioners showed the following present: Commissioners Bornstad, D'Elia, Hockaday, Lattimore, Szpond and Tomko.

Commissioners absent: Commissioner Salerno, Vice Chairwoman Rountree and Chairman Scutari.

Report of Executive Director, Committees, Staff and Counsel - Public Session I

a) Resolutions/Consent Agenda

Commissioners Tomko made a motion to approve resolution 48-2016, approving the Public and Executive meeting minutes of May 4, 2016 and The Public Session Minutes of May 12, 2016. The motion was seconded by Commissioner D'Elia and approved by all members present.

Commissioner Hockaday made a motion to approve resolution 49-2016 approving a bill list and the release of vouchers for processing and payment, subject to the certification that sufficient funds are available. The motion was seconded by Commissioner D'Elia and approved by all members present.

Clerk da Silva explained the details of resolution 50-2016, renewing Cooperative Purchasing Agreement with County of Union stating the previous agreement with the County was due to expire July 8, 2016. The motion was made by Commissioner Szpond and seconded by Commissioner Hockaday with all members present voting in the affirmative.

Commissioner Tomko made a motion to approve resolution 51-2016, making application to the Local Finance Board regarding City of Rahway refinancing of bonds. The motion was seconded by Commissioner Hockaday and approved by all my members present.

Mr. Sullivan asked Larry Uher of Netta Architects to provide the details of resolution 52-2016, authorizing an extended services agreement with Netta Architects in connection with the new Union County Family Court Building at Cherry Street in Elizabeth, New Jersey. Mr. Uher explained that the need for the extension is related to revising the fit out of space initially dedicated for the UCIA offices but now to be utilized by a division of the Prosecutor's office.

Sherriff Cryan, Captain Burke and Stephan Caruso presented to the Commissioner an explanation of resolution 53-2016, Approving Change Order No. 4 to the contract for construction of the new Union County Family Courthouse Building at Cherry Street, Elizabeth, New Jersey. The motion was made by Commissioner Szpond and seconded by Commissioner Hockaday with all members present voting in the affirmative.

Steve Bach of Pinnacle introduced and provided an overview of the details on resolution 54-2016 authorizing Change Order No. 60 for Alterations and Renovations to the Annex and Logos Buildings at Union County College, Plainfield Campus, in Plainfield, New Jersey; 55-2016 authorizing Change Order No. 70 for Alterations and Renovations to the Annex and Logos Buildings at Union County College, Plainfield Campus, in Plainfield, New Jersey; and 56-2016, Authorizing Change Order No. 71 for Alterations and Renovations to the Annex and Logos Buildings at Union County College, Plainfield Campus, in Plainfield, New Jersey. The motion was made by Commissioner Tomko and seconded by Commission D'Elia with all members present voting in favor.

Mr. Sullivan explained the details of resolution 57-2016, authorizing an amendment to the Lease Agreement between the Union County Improvement Authority and Dental Health Associates, P. A. in connection with the Park Madison Building in Plainfield, New Jersey. The motion was made by Commissioner Hockaday and Seconded by Commissioner Lattimore with all members present voting in the affirmative.

Report of Committees, Staff and Counsel – Executive Session.
