Report of Executive Director, Committees, Staff and Counsel - Public Session I

Resolutions/Consent Agenda

Commissioners Szpond made a motion to approve resolution 61-2016, approving the Public and Executive meeting minutes of June 8, 2016 and the Public Session Minutes of June 23, 2016. The motion was seconded by Commissioner Bornstad with all members present voting in the affirmative except Chairman Scutari abstained on the minutes of June 8, 2016; and Commissioner Salerno abstained on the minutes of June 23, 2016.

Commissioner Hockaday arrived at 12:02pm via teleconference.

Mr. Sullivan introduced resolution 62-2016, approving a bill list and the release of vouchers for processing and payment, subject to the certification that sufficient funds are available. Mr. Sullivan referred to a reimbursement being made to him which was related to the contributions he made towards the Public Employees Retirement System (PERS) which the Authority recently received notification that he was not eligible to participate since he already participates from the Union County Utilities Authority. He continued to state that all employees are required to go through the PERS enrollment process until the Authority is notified otherwise by the Division of Pensions and Benefits. The motion was made by Commissioner Bornstad and seconded by Commissioner Lattimore with all members present voting in the affirmative.
