RESOLUTION OF THE UNION COUNTY IMPROVEMENT AUTHORITY AUTHORIZING ITS INSURANCE BROKER, ACRISURE, LLC, TO RENEW THE AUTHORITY'S GENERAL LIABILITY PACKAGE AND EXCESS LIABILITY INSURANCE COVERAGES FOR THE PERIOD AUGUST 1, 2016 THROUGH JULY 31, 2017

WHEREAS, the Union County Improvement Authority (the "Authority") has been duly created by ordinance of the Union County Board of Chosen Freeholders as a public body corporate and politic of the State of New jersey pursuant to and in accordance with the County Improvement Authorities Law, constituting Chapter 183 of the Pamphlet Laws of 1960 of the State, as amended and supplemented from time to time (the "Act"); and

WHEREAS, in order to carry out the state purposes and goals for which the Authority was created, the Authority is required to maintain certain levels of insurance coverage to protect is officers, directors and employees, and its property and assets over which it has control; and

WHEREAS, the Authority's insurance broker, Acrisure, LLC, has presented the Authority with a proposal from American Alternative Insurance Corporation to renew the Authority's General Liability Package and Excess Liability Insurance coverages for the period August 1, 2016 through July 31, 2017 at a cost of \$78,656.77; and

WHEREAS, the purchase of insurance is exempt from public bidding and is pursuant to N.J.S.A. 40A:11-5(1)(m), subject to the requirements of extraordinary unspecifiable services, which have been satisfied,

NOW, THEREFORE, BE IT RESOLVED by the Union County Improvement Authority, that Acrisure, LLC be and is hereby authorized to renew the Authority's General Liability Package and Excess Liability Insurance coverages with American Alternative Insurance Corporation in accordance with its proposal in the amount of \$78,656.77; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.

Dear Mark;

Below please find the renewal program offered to the Union County Improvement Authority on behalf of American Alternative a division of Munich RE for all coverages, terms, conditions and exclusions as expiring except where noted below.

As you recall the UCIA expiring carrier had pulled out of the public entity program business in the state of New Jersey and non- renewed the program effective 08/01/2016. This required us to explore and market the UCIA coverage with very few options available as indicated.

THE FOLLOWING MARKETS DELINED TO QUOTE – RISK TOO SMALL, WOULD WANT TO PUT IN SELF INSURED RETENTION PROGRAM WITH HIGHER RETENTION ~ Travelers, Zurich, Chubb, Hanover, Great American, Liberty Mutual, Brit Global, Berkley PE Managers, Euclid Public Sector Program, Trident, Scottsdale & One Beacon

The Package premium increased overall by \$6,264 however the Umbrella premium did reflect a decrease of \$2,732 so there is an overall increase in premium of only \$3,408.77, however this program carries a higher aggregate limit of liability from 1MIL/2MIL to 1MIL/3MIL and a deductible decrease on the liability side from \$25,000 to \$15,000.

This American Alternative program is underwritten through Munich RE – one of the largest reinsurers in the county, and is specific to risks like the UCIA. There are a few Improvement Authority's in New Jersey currently covered by this program as well as quite a few Sewer and Water Authorities. Some of them are your neighbors at LRSA and RVSA.

This is an excellent fit with opportunity to be more inclusive in the future for additional/optional coverages available to the UCIA through this program.

# STANDARD CERTIFICATION DECLARATIONFOR AN EXTRAORDINARY UNSPECIFIABLE SERVICE

This is to request your approval of a resolution authorizing a contract to be executed as follows:

Firm: American Alternative Insurance Corporation, a division of Munich Reinsurance Company

Cost: \$78,656.77 (annual premium)

Duration: One year commencing August 1, 2016

Purpose: General Liability Package and Excess Liability Insurance Coverages

This is to request an award of a contract without the receipt of formal bids as an Extraordinary Unspecifiable Service [N.J.S.A. 40A:11-5(1)(a)(ii) and N.J.A.C. 5:34-2.3(b)]. I do hereby certify to the following:

1. Provide a clear description of the nature of the work to be done.

American Alternative Insurance Corporation will provide the Authority with general liability and excess insurance policies covering Authority property and assets.

2. Describe in detail why the contract meets the provisions of the statute and rules:

This is an insurance contract that is deemed an EUS pursuant to N.J.S.A. 40A:11-5(1)(m).

3. The service(s) is of such a specialized and qualitative nature that the performance of the service(s) cannot be reasonably described by written specifications because:

4. Describe the informal solicitation of quotations:

In addition to American Alternative Insurance Corporation, the Authority's insurance broker, Acrisure LLC, sought quotations from Chubb Insurance, Hanover Insurance, Traveler's Insurance, Liberty Mutual Insurance, Berekely PE Manager, Brit Global, Euclid, One Republic Insurance and Trident Insurance, all of whom decline to provide quotations because of the small size of the risk. Acrisure also sought a quotation from Scottsdale Insurance, but has not received a response.

5. I have reviewed the rules of the Division of Local Government Services pursuant to N.J.A.C. 5:34-2.1 et seq. and certify that the proposed contract may be considered an extraordinary unspecifiable service in accordance with the requirements thereof.
