RESOLUTION OF THE UNION COUNTY IMPPROVEMENT AUTHORITY REVISING THE ANNUAL MEETING FOR THE PERIOD JULY 2017 THROUGH THE AUTHORITY'S REORGANIZATION MEETING IN FEBRUARY 2018

WHEREAS, the Union County Improvement Authority (the "Authority"), a public body corporate and politic of the State of New Jersey, organized and existing under the provisions of the Municipal and County Improvement Authorities Law (N.J.S.A. 40:37A-44 et seq.) has heretofore been created by the governing body of the County of Union, New Jersey; and

WHEREAS, the Authority constitutes a "public body", as such term is defined in New Jersey Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.) and, as such, is required to provide "adequate notice" of any meetings and/or activities of the Authority in the manner provided in N.J.S.A 10:4-8(d); and

WHEREAS, in accordance with the provision of N.J.S.A. 10:4-18, at least once a year, within seven days following its annual reorganization meeting, the Authority is obligated to provide "adequate notice", as defined in N.J.S.A. 10:4-8(d), of the schedule of the regular meetings of the Authority to be held during the succeeding year; and

WHEREAS, the Authority has revised the meeting schedule for the period July 2017 through February 2018, as required by the New Jersey Open Public Meetings Act;

NOW, THEREFORE, BE IT RESOLVED, by the Union County Improvement Authority, as follows:

- 1. The revised meeting schedule for the period of July 2017 through February 2018 is attached here to as Attachment A
- 2. Unless otherwise notified, all regular meetings of the Authority shall be held at 5:00 p.m. at the Authority's administrative office located on the Third Floor of the Union County Resource Recovery Facility, 1499 Route 1 & 9 North, Rahway, New Jersey.
- 3. The staff of the Authority are hereby directed to take all actions as are required in order to satisfy the requirements of N.J.S.A. 10:4-18, including, but not limited to, (a) posting a notice of the meeting schedule in at least one public place reserved for such announcements, (b) providing the meeting schedule to the newspapers officially designated by the Authority to receive such notices, and (c) filing the meeting schedule with the Clerk of the County of Union, and mailing this Resolution (including the attached meeting schedule) to the Union County Manager and to the Clerk of the Board of Chosen Freeholders of the County of Union.
- 4. This Resolution shall take effect immediately.
