**RESOLUTION OF THE UNION COUNTY IMPROVEMENT AUTHORITY  
PROVIDING FOR THE ELECTION OF TREASURER  
TO FILL AN UNEXPIRED TERM**

**WHEREAS**, the Union County Improvement Authority (the “Authority”) has been duly created by an Ordinance of the Board of Chosen Freeholder of the County of Union, New Jersey as a public body, corporate and politic of the State of New Jersey pursuant to an in accordance with the County Improvement Authorities Law, N.J.S.A. 40:37A-44, et seq.; and

**WHEREAS**, New Jersey Statutes and the By-Laws for the Authority require and provide for the annual election of officers at the regularly scheduled Reorganization Meeting of the Authority in February of each year; and

**WHEREAS**, on February 5, 2020 the Board elected Commissioner John Salerno to the position of Treasurer for a term of one (1) year, expiring on February 3, 2021

**WHEREAS**, on July 1, 2020 the position of Treasurer is now vacant; and

**WHEREAS**, Article 1 Section 3.3 of the Authority’s By-Laws states “Should any office become vacant, the Board shall elect a successor from its membership at the next regular meeting, and such election shall be for the unexpired term of said office”; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Union County Improvement Authority has elected and hereby names Steven Gary Hornaday to serve as its Treasurer commencing August 5, 2020 and ending at the Authority’s next Reorganization Meeting on or about February 3, 2021 or until such time as it elects new officers at such Reorganization Meeting.

**BE IT FURTHER RESOLVED**, that this resolution shall take effect immediately.
