RESOLUTION OF THE UNION COUNTY IMPROVEMENT AUTHORITY REVISING THE ANNUAL MEETING SCHEDULE FOR THE PERIOD SEPTEMBER 2020 THROUGH THE AUTHORITY'S REORGANIZATION MEETING IN FEBRUARY 2021.

WHEREAS, the Union County Improvement Authority (the" Authority"), a public body corporate and politic of the State of New Jersey, organized and existing under the provisions of the Municipal and County Improvement Authorities Law (NJSA 40:37A-44 et seq.) has heretofore been created by the covering boy of the County of Union, New Jersey; and

WHEREAS, the Authority constitutes a "public body", as such term is defined in New Jersey Open Public Meeting Act (NJSA 10:4-1 et seq.) and, as such is required to provide "adequate notice" of any meeting and/or activities of the Authority in the Manner provided in the NJSA 10:4-8(d)l and

WHEREAS, in accordance with the provision of NJSA 10:4-8, as least once a year within seven days following its annual reorganization meeting, the Authority is obligated to provide "adequate notice", as defined in NJSA 10:4-8(d), of the schedule of the regular meetings of the Authority to be held during the succeeding year; and

WHEREAS, the Authority has revised the meeting schedule for the period September 2020 through February 2021 as required by the New Jersey Open Public Meetings Act;

NOW THEREFORE BE IT RESOLVED BY THE UNION COUNTY IMPROVEMENT AUTHORITY BOARD OF COMMISSIONERS:

- 1. The revised meeting schedule for the period September 2020 through February 2021 is attached hereto as Attachment A.
- 2. Unless otherwise notified, all regular meetings of the Authority shall be held at 5:00 p.m. at the Authority's administrative office located on the Thursday Floor of the Union County Resource Recovery Facility, 1499 Route 1&9 North, Rahway, New Jersey.
- 3. The Clerk of the Authority is hereby directed to take all actions as are required in order to satisfy the requirements of NJSA 10:4-8, including but not limited to, (a) posting a notice of the meeting schedule in at least one public place reserved for such announcements, (b) providing the meeting schedule to the newspapers officially designated by the Authority to receive such notices, and (c) filing the meeting schedule with the Clerk of the County of Union and mailing this resolution (including the attached meeting schedule) to the Union County Manager, and the Clerk of the Clerk of the Board of Freeholders of the County of Union.
- 4. This Resolution shall take effect immediately.
