APPROVING SETTLEMENT AGREEMENT AND RELEASE

WHEREAS, a regular meeting of the Union County Improvement Authority (the "Authority") was held on June 9, 2021; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), the Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts and things necessary, convenient or desirable for the purposes of the Authority, subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, Plaintiff AST filed a Complaint against the UCIA and other defendants, in the case of <u>AST Roselle</u>, <u>LLC v. The Borough of Roselle and The Union County Improvement Authority</u>, in the Superior Court of New Jersey, Law Division, Union County with Docket No. L-3019-18 (the "Litigation"); and

WHEREAS, the Authority and Plaintiff AST have settled all controversies among them after successful mediation for \$200,000 pending Commissioners approval; and

WHEREAS, the parties now seek approval of the Settlement Agreement and Release resolving the Lawsuit and all controversies between them;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE MEMBERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:
