APPROVING CONTRACT ADDENDUM TO EXTEND PROPERTY MANAGEMENT SERVICES AGREEMENT FOR AN ADDITIONAL MONTH FOR PROPERTY MANAGEMENT SERVICES AT GERALD B. GREEN PLAZA

WHEREAS, the Authority contracted for the provision of property management services at Gerald B. Green Plaza with Nobel Property Management, LLC (the "Services"); and

WHEREAS, the Authority by Resolution #74-2017, duly adopted on December 7, 2017, authorized an Agreement with Nobel Property Management, LLC for the provision of the Service; and

WHEREAS, Nobel Property Management provided prior written notice of their request to terminate and cancel the Agreement as set forth in Section 15. of the contract and requested a termination date effective July 1, 2021, which was granted by the Authority; and

WHEREAS, the Authority would like to continue their services for an additional month from July 1, 2021 through July 31, 2021; and

WHEREAS, the Authority would like to amend the approved expiration date of the contract for the vendor, Nobel Property Management, LLC, for the provision of property management services at Gerald B. Green Plaza and to extend the services for an additional month from July 1, 2021 through July 31, 2021, in accordance with this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:
