RESOLUTION AWARDING A CONTRACT TO SUPLEE CLOONEY & COMPANY TO PERFORM STATUTORY AUDIT OF ACCOUNTS OF THE UNION COUNTY IMPROVEMENT AUTHORITY

WHEREAS, the Union County Improvement Authority (the "Authority") has been duly created by Ordinance of the Union County Board of County Commissioners, as a public body corporate and politic of the State of New Jersey pursuant to and in accordance with the County Improvement Authorities Law, N.J.S.A. 40:37A-44, *et seq.*; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), the Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts and things necessary, convenient or desirable for the purposes of the Authority, subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, there exists the need to for Auditing Services for accounts as of yearend December 2022; and

WHEREAS, pursuant to a "fair and open process" conducted through a Request for Qualifications and by way of Resolution No. 14-2022, the Authority has approved a list of prequalified firms to provide Auditing Services to the Authority, in which Suplee, Clooney & Company is listed; and

WHEREAS, Suplee, Clooney & Company, 308 E Broad St., Westfield, NJ 07090 has agreed to provide the necessary services as outlined above and consistent with their proposal; and

WHEREAS, the Local Public Contracts Law requires that a resolution authorizing the awarding of a contract for professional services "without competitive bidding" be passed by the governing body and shall be advertised and be available for inspection by members of the public; and
