RESOLUTION AWARDING A CONTRACT TO ACRISURE, LLC FOR INSURANCE BROKERAGE SERVICES

WHEREAS, the Union County Improvement Authority (the "Authority") has been duly created by Ordinance of the Union County Board of County Commissioners, as a public body corporate and politic of the State of New Jersey pursuant to and in accordance with the County Improvement Authorities Law, N.J.S.A. 40:37A-44, *et seq.*; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), the Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts and things necessary, convenient or desirable for the purposes of the Authority, subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, there exists the need to for Insurance Brokerage Services for the period of February 9, 2022 through March 8, 2023; and

WHEREAS, pursuant to a "fair and open process" conducted through a Request for Qualifications and by way of Resolution No. 14-2022, the Authority has approved a list of prequalified firms to provide Insurance Brokerage Services to the Authority, in which Acrisure, LLC is listed; and

WHEREAS, Acrisure, LLC, Woodbridge, NJ has agreed to provide the necessary services as outlined above and consistent with their proposal; and

WHEREAS, the Local Public Contracts Law requires that a resolution authorizing the awarding of a contract for professional services "without competitive bidding" be passed by the governing body and shall be advertised and be available for inspection by members of the public; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Union County Improvement Authority a contract to Acrisure, LLC, Tampa, FL, is hereby awarded pursuant to a fair and open process, to provide Insurance Brokerage Services in an amount not to exceed \$100,000 for the period of February 9, 2022 through March 8, 2023; and
