RESOLUTION APPROVING PURCHASE THROUGH UNION COUNTY COOPERATIVE PRICING SYSTEM FOR LOW VOLTAGE CABLING AND AUDIO VISUAL SYSTEM FROM JCT SOLUTIONS

WHEREAS, a regular meeting of the Union County Improvement Authority (the "Authority") was held on October 12, 2022; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t) a county improvement authority is empowered to enter into any and all agreements or contracts, execute any and all instruments and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the Authority or to carry out any power given in the County Improvement Authorities Law, N.J.S.A. 40:37A-44 et seq. (the "Act"), subject to the Local Public Contracts Law, N.J.S.A. 40A: 11-1 et seq.; and

WHEREAS, pursuant to N.J.S.A. 40A:11-11(5), two or more contracting units may establish a Cooperative Pricing System for the provision and performance of goods and services and enter into a cooperative pricing agreement for its administration; and

WHEREAS, the Union County Cooperative (the "Cooperative") has established a voluntary Cooperative Pricing System (the "System") with other contracting units to effect substantial economies in the provision and performance of goods and services; and

WHEREAS, the Cooperative has certain products and services included in the System; and

WHEREAS, on September 14, 2022, the Authority enacted Resolution No. 52-2022 in which the Authority entered into a contract with Terminal Construction Corp. for the Roselle Library Alteration and Addition Project (hereinafter referred to as "Project") in an amount not to exceed \$11,300,000.00; and

WHEREAS, the Authority is in need of Low Voltage Cabling and an Audio Visual System for the Roselle Library Project which is available through the Union County Cooperative #24-2021 from JCT Solutions;
