RESOLUTION AUTHORIZING EXECUTION OF A PROFESSIONAL SERVICES CONTRACT WITH COLLIERS ENGINEERING & DESIGN, INC TO UPDATE THE ASBESTOS ABATEMENT SURVEY FOR THE ROSELLE PUBLIC LIBRARY

WHEREAS, the Authority has been duly created by ordinance of the Union County Board of Commissioners as a public body corporate and politic in the State of New Jersey pursuant to and in accordance with the County Improvement Authorities Law, N.J.S.A. 40A:37A-44 *et. seq.*; and

WHEREAS, on January 13, 2021 the Authority enacted Resolution No. 8-2021 which authorized a Shared Services Agreement with the Borough of Roselle in connection with the renovation and expansion of the Borough of Roselle Public Library (hereinafter referred to as the "Project"); and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-5, the Authority may procure professional services without the necessity of advertising for bids pursuant to <u>N.J.S.A.</u> 40A:11-1, *et. seq.*; and

WHEREAS, the Construction Manager, Pinnacle Consulting and Construction Services noticed areas of disturbance in the Project expansion areas which were not included in the original asbestos survey; and

WHEREAS, Colliers Engineering & Design, Inc. (DBA Maser Consulting) conducted the original survey, which was summarized by a letter dated November 16, 2018; and

WHEREAS, Colliers Engineering & Design, Inc. submitted a proposal dated October 28, 2022 indicating that an updated asbestos abatement survey for the Project will cost an amount not to exceed \$26,500.00; and

- 2. The Authority authorizes that the Chairman of the Authority to approve and execute a contract with Colliers Engineering & Design, Inc in substantially similar form attached with such changes shall be approved by the Chairman on advice of counsel. Such approval and execution by the Chairman shall be deemed approved by the authority and no further action or approval is required.

AND BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.
