## RESOLUTION APPOINTING BIBI TAYLOR AS EXECUTIVE DIRECTOR, QUALIFYING PURCHASING AGENT, AND FINANCE OFFICER FOR THE UNION COUNTY IMPROVEMENT AUTHORITY

**WHEREAS,** the Authority has been duly created by ordinance of the Union County Board of Commissioners as a public body corporate and politic in the State of New Jersey pursuant to and in accordance with the County Improvement Authorities Law, <u>N.J.S.A.</u> 40:37A-44 *et. seq.*; and

**WHEREAS,** pursuant to <u>N.J.S.A.</u> 40:37A-49 the Authority is permitted to appoint an Executive Director and other employees as it may require without regarding to Title 11A, New Jersey Civil Service Statute; and

**WHEREAS,** the Executive Director shall perform the administrative duties and control the day to day operations as designated by the Authority and as detailed in the Bylaws Section 6.4(a)

WHEREAS, Bibi Taylor currently serves as the Project Manager for the Authority; and

**WHEREAS,** the Authority wishes to formally appoint Bibi Taylor as the Executive Director, Qualified Purchasing Agent and Chief Financial Officer; and

**WHEREAS,** Bibi Taylor, holds a Qualified Purchasing Agent License and a Chief Financial Officer's License; and

**WHEREAS,** the County of Union shall remunerate Bibi Taylor, a County employee, via a stipend as aid to the Authority consistent with N.J.S.A. 40:37A-76 for her services to the Authority; and
