**RESOLUTION APPOINTING RAINONE, COUGHLIN,
MINCHELLO, LLC AS REDEVELOPMENT COUNSEL TO THE UNION
COUNTY IMPROVEMENT AUTHORITY**

WHEREAS, the Union County Improvement Authority (the "Authority") has been duly created by Ordinance of the Union County Board of County Commissioners, as a public body corporate and politic of the State of New Jersey pursuant to and in accordance with the County Improvement Authorities Law, N.J.S.A. 40:37A-44, *et seq.*; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), the Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts and things necessary, convenient or desirable for the purposes of the Authority, subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*; and

WHEREAS, there exists the need to for Redevelopment Counsel Services for the period of February 9, 2023 through February 8, 2024; and

WHEREAS, pursuant to a "fair and open process" conducted through a Request for Qualifications and by way of Resolution No. 10-2023, the Authority has approved a list of pre-qualified firms to provide Redevelopment Counsel Services to the Authority, in which Rainone, Coughlin & Minchello, LLC is listed; and

WHEREAS, Rainone, Coughlin & Minchello, LLC, 555 US-1, Iselin, NJ 08830 has agreed to provide the necessary services as outlined above in the amount not to exceed \$200,000.00 at an hourly rate for partner of \$185 as outlined in their proposal; and

WHEREAS, the Local Public Contracts Law requires that a resolution authorizing the awarding of a contract for professional services "without competitive bidding" be passed by the governing body and shall be advertised and be available for inspection by members of the public; and
