RESOLUTION REJECTING QUALIFICATION STATEMENTS FOR AUDITING SERVICES

WHEREAS, pursuant to <u>N.J.S.A.</u> 40:37A-55(t), a county improvement authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do perform any and all acts or things necessary, convenient or desirable for the purposes of the authority subject to the "Local Public Contracts Law," <u>N.J.S.A.</u> 40A:11-1, *et. seq.*; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-5(1)(a)(i), any contract, purchase or agreement, the subject matter of which consists of professional services is an exception to the public bidding requirements of the Local Public Contracts Law; and

WHEREAS, on December 29, 2022, in accordance with <u>N.J.S.A.</u> 19:44A-20.4 *et. seq.* the Authority undertook a fair and open process and advertised a request for qualifications for the provision of auditing services for the year 2023; and

WHEREAS, the Authority received two (2) qualification statements from Suplee, Clooney & Company and Lerch Vinci & Bliss in response to the request for qualifications; and

WHEREAS, the Authority reserves the right to reject for any reason and all qualification statements and components thereof; and

WHEREAS, the Authority wishes to reject the received qualification statements as a fee schedule request was not included in the notice of request for qualifications; and
