## RESOLUTION AUTHORIZING A GUARANTEED MAXIMUM PRICE PROFESSIONAL SERVICES CONTRACT TO REMINGTON AND VERNICK FOR GENERAL ENGINEERING SERVICES FOR THE SPRINGFIELD AVENUE PARK IMPROVEMENTS

**WHEREAS,** a special meeting of the Union County Improvement Authority (hereinafter referred to as the "Authority") was held on June 28, 2023; and

**WHEREAS,** the Authority has been duly created by ordinance of the Board of Chosen Commissioners of the County of Union, a public body corporate and politic of the State of New Jersey pursuant to and in accordance with the County Improvement Authority law, <u>N.J.S.A.</u> 40:37A-44, *et. seq.*; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40:37A-55(t), a County Improvement Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the authority subject to the "Local Public Contracts Law," N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS,** in accordance with <u>N.J.S.A.</u> 19:44A-20.4 et seq., the Authority undertook a fair and open process and advertised a request for qualifications for the provision of the Services; and

**WHEREAS,** on February 8, 2023, the Authority enacted Resolution No. 10-2023 which prequalified various vendors and firms to perform consulting and professional services for the Authority, including general engineering services; and

WHEREAS, the Authority is desirous of engaging a pre-qualified firm to provide general engineering services for improvements to Springfield Avenue Park in Berkeley Heights, New Jersey; and

**WHEREAS,** Remington and Vernick Engineers is pre-qualified and experienced in the field in which professional services will be rendered; and

**WHEREAS,** the Authority desires to enter into a contract with Remington and Vernick Engineers to perform general engineering services related to the Springfield Avenue Park Improvements pursuant to their proposal dated June 6, 2023.

## NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE COMMISSIONERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby appoints Remington and Vernick Engineers to perform general engineering services related to the Springfield Avenue Park improvements.
- 2. A contract for general engineering services be and is hereby awarded to Remington and Vernick Engineers having offices located at 2059 Springdale Road, Cherry Hill, New Jersey 08003 in connection with the Springfield Avenue Park improvements at a Guaranteed Maximum Price of \$324,450.00 (Three Hundred and Twenty Four Thousand, Four Hundred and Fifty Dollars).
- 3. The Authority authorizes the Chairman to execute a contract with Remington and Vernick Engineers setting forth the terms of the provisions of the Services pursuant to the proposal attached hereto. Such execution by the Chairman shall be deemed approval by the Authority and no further action or approval shall be required.
- 4. The Executive Director is directed to publish a notice of award of contracts in the official newspaper in accordance with <u>N.J.S.A.</u> 40A:11-5(1)(a)(i).
- 5. This Resolution shall take effect immediately.
