## RESOLUTION AUTHORIZING A GUARANTEED MAXIMUM PRICE PROFESSIONAL SERVICES CONTRACT WITH KS ENGINEERS, P.C. FOR GENERAL ENGINEERING SERVICES FOR ECHO LAKE DOG PARK IMPROVEMENTS

**WHEREAS,** a special meeting of the Union County Improvement Authority (hereinafter referred to as the "Authority") was held on June 28, 2023; and

**WHEREAS,** the Authority has been duly created by ordinance of the Board of Chosen Commissioners of the County of Union, a public body corporate and politic of the State of New Jersey pursuant to and in accordance with the County Improvement Authority law, <u>N.J.S.A.</u> 40:37A-44, *et. seq.*; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40:37A-55(t), a County Improvement Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the authority subject to the "Local Public Contracts Law," <u>N.J.S.A.</u> 40A:11-1, et seq.; and

**WHEREAS,** in accordance with <u>N.J.S.A.</u> 19:44A-20.4 et seq., the Authority undertook a fair and open process and advertised a request for qualifications for the provision of the Services; and

**WHEREAS,** on February 8, 2023, the Authority enacted Resolution No. 10-2023 which prequalified various vendors and firms to perform consulting and professional services for the Authority, including general engineering services; and

WHEREAS, the Authority is desirous of engaging a pre-qualified firm to provide general engineering services for improvements to Echo Lake Dog Park in Mountainside, New Jersey; and

Resolution No. 53-2023 Adoption Date June 28, 2023 **WHEREAS,** KS Engineers, P.C. is pre-qualified and experienced in the field in which professional services will be rendered; and

**WHEREAS,** the Authority desires to enter into a contract with K.S. Engineers, P.C. to perform general engineering services related to the Echo Lake Dog Park Improvements pursuant to their proposal dated June 6, 2023.

## NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE COMMISSIONERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby appoints K.S. Engineers, P.C. to perform general engineering services related to the Echo Lake Dog Park improvements.
- 2. A contract for general engineering services be and is hereby awarded to K.S. Engineers, P.C. having offices located at 2 Riverfront Plaza, 3<sup>rd</sup> Floor, Newark, New Jersey 07102 in connection with the Echo Lake Dog Park improvements at a Guaranteed Maximum Price of \$124,300.00 (One Hundred and Twenty Four Thousand, Three Hundred Dollars).
- 3. The Authority authorizes the Chairman to execute a contract with K.S. Engineers, P.C. setting forth the terms of the provisions of the Services pursuant to the proposal attached hereto. Such execution by the Chairman shall be deemed approval by the Authority and no further action or approval shall be required.
- 4. The Executive Director is directed to publish a notice of award of contracts in the official newspaper in accordance with <u>N.J.S.A.</u> 40A:11-5(1)(a)(i).
- 5. This Resolution shall take effect immediately.
