**RESOLUTION AWARDING A CONTRACT TO BLX GROUP FOR
 ARBITRAGE REBATE ANALYSIS SERVICES**

WHEREAS, the Union County Improvement Authority (the "Authority") has been duly created by Ordinance of the Union County Board of County Commissioners, as a public body corporate and politic of the State of New Jersey pursuant to and in accordance with the County Improvement Authorities Law, N.J.S.A. 40:37A-44, *et seq.*; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), the Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts and things necessary, convenient or desirable for the purposes of the Authority, subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*; and

WHEREAS, there exists the need to for Arbitrage Rebate Analysis Services for the period of February 6, 2024 through February 5, 2025; and

WHEREAS, pursuant to a "fair and open process" conducted through a Request for Qualifications and by way of Resolution No. 10-2024, the Authority has approved a list of pre-qualified firms to provide Arbitrage Rebate Analysis Services to the Authority, in which BLX Group LLC is listed; and

WHEREAS, BLX Group LLC, 4300 W Cypress St., Suite 360, Tampa, FL 33607 has agreed to provide the necessary services as outlined above in the amount not to exceed \$12,000.00 and consistent with the rates outlined in their proposal; and

WHEREAS, the Local Public Contracts Law requires that a resolution authorizing the awarding of a contract for professional services "without competitive bidding" be passed by the governing body and shall be advertised and be available for inspection by members of the public; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Union County Improvement Authority a contract to BLX Group LLC, Tampa, FL, is hereby awarded pursuant to a fair and open process, to provide Arbitrage Rebate Analysis Services for the period of February 6, 2024 through February 5, 2025 in the amount not to exceed \$12,000.00; and

BE IT FURTHER RESOLVED that the Chairman of the Authority is hereby authorized to sign any and all documents necessary to effectuate said contract; and

BE IT FURTHER RESOLVED that notice of this Resolution shall be published according to law.
