## RESOLUTION AUTHORIZING CONTRACT AMENDMENT TO REMINGTON AND VERNICK ENGINEERS FOR ADDITIONAL GENERAL ENGINEERING SERVICES FOR THE SPRINGFIELD AVENUE PARK IMPROVEMENT PROJECT

**WHEREAS,** pursuant to N.J.S.A. 40:37A-55(t), the Authority is empowered to enter into any and all agreements, contracts, execute any and all instruments, and do and perform any and all acts and things necessary, convenient or desirable for the purposes of the Authority, subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1, *et. seq.*; and

**WHEREAS,** on June 28, 2023, the Authority enacted Resolution No. 49-2023 and awarded a professional services contract to Remington and Vernick Engineers for a Guaranteed Maximum Price of Three Hundred and Twenty-Four Thousand, Four Hundred and Fifty Dollars and xx/100 (\$324,450.00) for general engineering services related to the Springfield Avenue Park improvements; and

WHEREAS, on March 29, 2024, Remington and Vernick Engineers provided an additional proposal to the Authority for the surveying, wetland delineation, and permit preparation and submission for clearing of the Passaic River in the vicinity of Springfield Avenue Park in a two (2) phase approach at cost not to exceed Fifty Thousand Dollars (\$50,000.00); and

**WHEREAS,** the first phase will consist of a global positioning system control points and field survey, office and drafting work, and wetland delineation for a total cost of Thirty Thousand Dollars (\$30,000.00) and the second phase will consist of the New Jersey Department of Environmental Protection permit preparation for a total cost of Twenty Thousand Dollars (\$20,000.00); and

**WHEREAS,** Remington and Vernick Engineer's additional scope of services is necessary to keep the Springfield Avenue Park improvement project moving forward and to avoid unnecessary delays; and

**WHEREAS,** the Authority authorizes the additional funding to Remington and Vernick Engineers in the amount of Fifty Thousand Dollars (\$50,000.00) for a new contract value of Three Hundred and Seventy Four Thousand, Four Hundred and Fifty Dollars xx/100 (\$374,450.00).

## NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE COMMISSIONERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby authorizes an increase in the funding of \$50,000.00 awarded to Remington and Vernick Engineers for the Springfield Avenue Park improvements at a cost not to exceed \$374,450.00.
- 2. The Authority hereby authorizes the Chairman to execute any and all amendments to the original contract with Remington and Vernick Engineers setting forth the provisions of the additional scope of services attached hereto. Such execution shall be deemed approved by the Authority and no further action or approval shall be required.
- 3. This Resolution shall take effect immediately.
