## RESOLUTION AUTHORIZING A CONTRACT FOR CONSTRUCTION SERVICES TO Z TECH CONTRACTING, LLC FOR THE SPRINGFIELD AVENUE PARK IMPROVEMENTS

**WHEREAS,** pursuant to N.J.S.A. 40:37A-55(t), a County Improvement Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and perform any and all acts or things necessary, convenient or desirable for the purpose of the Authority subject to the "Local Public Contracts Law," N.J.S.A. 40A:11-1, *et. seq.*; and

**WHEREAS,** the Authority desires the development and improvements to a Union County-owned park located at 735-737 Springfield Avenue, Berkeley Heights, New Jersey, (hereinafter referred to as the "Springfield Avenue Park Project"); and

**WHEREAS,** the Springfield Avenue Park Project includes construction of playground areas with shade structures, walking paths, a multi-purpose walking trail along the Passaic River, restroom facility, boat launches, storage sheds, walking track with pavilion, irrigation and landscaping; and

**WHEREAS,** three (3) bids were received for the Springfield Avenue Park Project on October 29, 2024, at 11:00 a.m. are as follows:

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. A contract for construction services is hereby awarded to Z Tech Contracting, LLC located at 1207 US Highway 22, Mountainside, New Jersey 07092 in connection with the Springfield Avenue Park Project in an amount not to exceed Four Million, Seven Hundred and Eight Thousand, Six Hundred and Seventy-Seven (\$4,708,677.00) Dollars
- 2. The Authority authorizes the Chairman to execute a contract with Z Tech Contracting, LLC setting forth the terms of the provision for services pursuant to the proposal attached hereto. Such execution by the Chairman shall be deemed approval by the Authority and no further action or approval shall be required.
