RESOLUTION AWARDING A CONTRACT TO SHAW INTEGRATED AND TURF SOLUTIONS, INC. FOR THE TURF FIELD AT LIGHTNING BROOK PARK UNION, NEW JERSEY

WHEREAS, pursuant to <u>N.J.S.A.</u> 40:37A-55(t), a County Improvement Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the Authority subject to the "Local Public Contracts Law," <u>N.J.S.A.</u> 40A:11-1, *et. seq.*; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-12(a), the Authority may without advertising for bids, purchase any goods or services under any contract for such goods or services entered into on behalf of the State of New Jersey, Department of Treasury, Division of Purchase and Property; and

WHEREAS, as part of the Lightning Brook Park renovation project the Authority wishes to install synthetic turf for the baseball and soccer field; and

WHEREAS, the Authority desires to use Shaw Integrated and Turf Solutions, Inc. (Vendor No. V00051261) through the New Jersey State Cooperative Purchasing Program for the following services:

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby awards a contract through the New Jersey State Cooperative Purchasing Program to Shaw Integrated and Turf Solutions, Inc., (Vendor No. V00051261), 185 South Industrial Boulevard, Calhoun, Georgia 30701 for the installation of a synthetic turf, base line letters and greens groomer, for the baseball and soccer field at Lightning Brook Park as a cost not to exceed Three Hundred and Seventy Thousand, Five Hundred and Thirty-One (\$370,531.00) Dollars.
- 2. The Authority authorizes the Chairman of the Authority to approve and execute a contract with Shaw Integrated and Turf Solutions, Inc. Such approval and execution by the Chairman shall be deemed approval by the Authority and no further action or approval shall be required.
