**RESOLUTION AUTHORIZING AN AMENDMENT TO THE PROFESSIONAL SERVICES CONTRACT AWARDED TO COLLIERS ENGINEERING AND DESIGN, INC. FOR GENERAL ENGINEERING SERVICES FOR THE GLENSIDE AVENUE PARK IMPROVEMENTS**

**WHEREAS**, pursuant to N.J.S.A. 40:37A-55(t), a County Improvement Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the authority subject to the "Local Public Contracts Law," N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, on June 28, 2023, the Authority enacted Resolution No. 52-2023 and awarded a professional services contract to Colliers Engineering and Design, Inc. for general engineering services for improvements to Glenside Avenue Park in Scotch Plains, New Jersey at a price not to exceed Six Hundred and Three Thousand, Four Hundred (\$603,400.00) Dollars; and

**WHEREAS**, the New Jersey Department of Environmental Protection and the State Historic Preservation Office reviewed the permit package for this project; and

**WHEREAS**, based upon the comments received from the New Jersey Department of Environmental Protection and State Historic Preservation Office, additional design services are warranted, including environmental services, cultural resources field work, pedestrian bridge design and drawings, and final project administration; and

**WHEREAS**, the Construction Manager recommends increasing Colliers Engineering and Design, Inc.'s current contract by \$52,500.00 for an amount not to exceed Six Hundred and Fifty-Five Thousand, Nine Hundred (\$655,900.00) Dollars; and

**WHEREAS**, the Authority would like to increase Colliers Engineering and Design, Inc.'s current contract by \$52,500.00 for an amount new amount not to exceed Six Hundred and Fifty-Five Thousand, Nine Hundred (\$655,900.00) Dollars.
