## RESOLUTION AUTHORIZING A CONTRACT AMENDMENT TO REMINGTON AND VERNICK ENGINEERS FOR ADDITIONAL GENERAL ENGINEERING SERVICES FOR THE SPRINGFIELD AVENUE PARK IMPROVEMENTS PROJECT

**WHEREAS,** pursuant to <u>N.J.S.A.</u> 40:37A-55(t), a County Improvement Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and perform any and all acts or things necessary, convenient or desirable for the purpose of the Authority subject to the "Local Public Contracts Law," <u>N.J.S.A.</u> 40A:11-1, *et. seq.*; and

**WHEREAS,** on June 28, 2023, the Authority enacted Resolution No. 49-2023 and awarded a professional services contract to Remington and Vernick Engineers for a Guaranteed Maximum Price of Three Hundred and Twenty-Four Thousand, Four Hundred and Fifty (\$324,450.00) Dollars for general engineering services related to the Springfield Avenue Park Improvements Project; and

**WHEREAS,** on May 7, 2024, the Authority enacted Resolution No. 43-2024 authorizing additional funding to Remington and Vernick Engineers in the amount of Fifty Thousand (\$50,000.00) Dollars for additional work for the surveying, wetland delineation, and permit preparation and submission for clearing of the Passaic River for a new contract amount of Three Hundred and Seventy-Four Thousand, Four Hundred and Fifty (\$374,450.00) Dollars; and

**WHEREAS,** the New Jersey State Historic Preservation Office is requiring Remington and Vernick Engineers to conduct a Phase I Archaeological Survey as part of the Springfield Avenue Park Improvement Project; and

**WHEREAS,** Remington and Vernick Engineers submitted an additional proposal to the Authority to complete this required work at a cost not to exceed Fifty Thousand (\$50,000.00) Dollars; and

**WHEREAS,** Remington and Vernick Engineers' additional scope of services is necessary to keep the Springfield Avenue Park Improvement Project moving forward and to avoid any unnecessary delays; and

**WHEREAS,** the Authority authorizes the additional funding to Remington and Vernick Engineers in the amount of Fifty Thousand (\$50,000.00) Dollars for a new contract value of Four Hundred and Twenty-Four Thousand Four Hundred and Fifty (\$424,450.00) Dollars.

## NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE COMMISSIONERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby authorizes an increase in funding in the amount of Fifty Thousand (\$50,000.00) Dollars for a new contract value of Four Hundred and Twenty-Four Thousand Four Hundred and Fifty (\$424,450.00) Dollars in order to conduct the Phase I Archaeological Survey as required for the Springfield Avenue Park Improvement Project.
- 2. The Authority hereby authorizes the Chairman to execute any and all amendments to the original contract with Remington and Vernick Engineers setting forth the provisions of the additional scope of services. Such execution shall be deemed approved by the Authority and no further action or approval shall be required.
- 3. This Resolution shall take effect immediately.
