RESOLUTION AWARDING A CONTRACT TO MECHANICAL SERVICES CORPORATION FOR HVAC AND VAV MAINTENANCE SERVICES FOR THE ASSEMBLYMAN GERALD B. GREEN PLAZA BUILDING, 200 WEST SECOND STREET, PLAINFIELD, NEW JERSEY

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), a County Improvement Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and perform any and all acts or things necessary, convenient or desirable for the purpose of the Authority subject to the "Local Public Contracts Law," N.J.S.A. 40A:11-1, *et. seq.*; and

WHEREAS, on June 25, 2024, the Authority enacted Resolution No. 50-2024 and awarded a contract to St Allen Realty Management, Inc. (hereinafter referred to as the "Property Manager") to provide Property Management Services at the Assemblyman Gerald B. Green Plaza Building, 200 West Second Street, Plainfield, New Jersey; and

WHEREAS, the Property Manager has identified a need for heating ventilation and air conditioning (hereinafter referred to as "HVAC") and variable air volume (hereinafter referred to as "VAV") services for the Gerald B. Green Plaza Building, 200 West Second Street, Plainfield, New Jersey; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-12(a), the Authority may without advertising for bids, purchase any goods or services under any contract for such goods and services entered into on behalf of the State of New Jersey, Department of Treasury, Division of Purchase and Property; and

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby awards a contract to Mechanical Services Corporation 41 South Jefferson Road, Whippany, New Jersey 07981 for a one (1) year term to perform HVAC and VAV Maintenance Services for the Assemblyman Gerald B. Green Plaza Building, 200 West Second Street, Plainfield, New Jersey, at a cost not to exceed Twenty-Nine Thousand Eighty-Nine (\$29,089.00) Dollars.
- 2. The Authority authorizes the Chairman to approve and execute a contract with Mechanical Services Corporation setting for the terms of the provision of HVAC and VAV maintenance services. Such approval and execution by the Chairman shall be deemed approval by the Authority and no further action or approval shall be required.
