**RESOLUTION AWARDING A GUARANTEED MAXIMUM PRICE PROFESSIONAL SERVICES CONTRACT TO RSC ARCHITECTS FOR ARCHITECTURAL SERVICES TO THE UNION COUNTY IMPROVEMENT AUTHORITY FOR VARIOUS PARKS PROJECTS**

WHEREAS, the Union County Improvement Authority (the "Authority") has been duly created by Ordinance of the Union County Board of County Commissioners, as a public body corporate and politic of the State of New Jersey pursuant to and in accordance with the County Improvement Authorities Law, N.J.S.A. 40:37A-44, *et seq.*; and

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), the Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts and things necessary, convenient or desirable for the purposes of the Authority, subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*; and

WHEREAS, there exists the need for Architectural Services for the upgrade and renovation to various County owned park facilities: (i.e., Warinanco Park – Turf Field, Deserted Village Roof Replacement, Trailside Nature Center – Sensory Trail, and Trailside Museum – Septic System); and

WHEREAS, pursuant to a "fair and open process" conducted through a Request for Qualifications and by way of Resolution No. 10-2025, the Authority has approved a list of pre-qualified firms to provide Architectural Services to the Authority, in which RSC Architects is listed; and

WHEREAS, RSC Architects, 3 University Plaza Drive, Suite 600, Hackensack, NJ 07601 has agreed to provide the necessary services as outlined above in the amount not to exceed \$985,000 as outlined in their proposal; and

WHEREAS, the Local Public Contracts Law requires that a resolution authorizing the awarding of a contract for professional services "without competitive bidding" be passed by the

WHEREAS, this contract is awarded without competitive bidding as a “Professional Service” in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts Law because the services to be provided are in the profession of law requiring considerable training and specialized study:

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Union County Improvement Authority a contract to RSC Architects, 3 University Plaza Drive, Suite 600, Hackensack, NJ 07601, is hereby awarded pursuant to a fair and open process, to provide architectural services to upgrade and renovate various County owned park facilities: (i.e. Warinanco Park – Turf Field, Deserted Village Roof Replacement, Trailside Nature Center – Sensory Trail, and Trailside Museum – Septic System); at a guaranteed maximum price of \$985,000; and

BE IT FURTHER RESOLVED that the Chairman of the Authority is hereby authorized to sign any and all documents necessary to effectuate said contract; and

BE IT FURTHER RESOLVED that notice of this Resolution shall be published according to law.
