**RESOLUTION AMENDING CONTRACT TO JCT SOLUTIONS FOR THE
 LIGHTNING BROOK PARK PROJECT AWARDED VIA THE UNION COUNTY
 COOPERATIVE PRICING FOR LOW VOLTAGE WIRING, NETWORK & SECURITY
 SYSTEMS**

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t) a county improvement authority is empowered to enter into any and all agreements or contracts, execute any and all instruments and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the Authority or to carry out any power given in the County Improvement Authorities Law, N.J.S.A. 40:37A-44 et seq. (the “Act”), subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, pursuant to N.J.S.A. 40A:11-11(5), two or more contracting units may establish a Cooperative Pricing System for the provision and performance of goods and services and enter into a cooperative pricing agreement for its administration; and

WHEREAS, the Union County Cooperative (the “Cooperative”) has established a voluntary Cooperative Pricing System (the “System”) with other contracting units to effect substantial economies in the provision and performance of goods and services; and

WHEREAS, the Cooperative has certain products and services included in the System; and

WHEREAS, the Authority adopted Resolution 35-2025 on April 1, 2025 awarding a contract to JCT Solutions for the Lightning Brook Park Project via the Union County Cooperative #8-2022 inclusive of Low Voltage Wiring, Emergency Blue Phones, Public WiFi and Camera System in an amount not to exceed \$295,494.41; and

WHEREAS, the Authority wishes to reduce the contract by \$145,914.46 for a new contract not to exceed \$149,579.95.
