**RESOLUTION AWARDING A CONTRACT TO JCT SOLUTIONS FOR THE
 SPRINGFIELD AVENUE PARK, GREEN LANE PARK, AND GLENSIDE AVENUE
 PARK PROJECTS VIA THE UNION COUNTY COOPERATIVE PRICING FOR LOW
 VOLTAGE WIRING, NETWORK & SECURITY SYSTEMS**

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t) a county improvement authority is empowered to enter into any and all agreements or contracts, execute any and all instruments and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the Authority or to carry out any power given in the County Improvement Authorities Law, N.J.S.A. 40:37A-44 et seq. (the “Act”), subject to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, pursuant to N.J.S.A. 40A:11-11(5), two or more contracting units may establish a Cooperative Pricing System for the provision and performance of goods and services and enter into a cooperative pricing agreement for its administration; and

WHEREAS, the Union County Cooperative (the “Cooperative”) has established a voluntary Cooperative Pricing System (the “System”) with other contracting units to effect substantial economies in the provision and performance of goods and services; and

WHEREAS, the Cooperative has certain products and services included in the System; and

WHEREAS, the Authority wishes to award a contract to JCT Solutions for installation of Low Voltage Wiring, Emergency Blue Phones, Public WiFi and Camera Systems at the Springfield Avenue Park, Green Lane Park, and Glenside Avenue Park Projects via the Union County Cooperative #8-2022 in an amount not to exceed \$368,378.18 (Springfield Avenue Park - \$169,497.37; Green Lane Park - \$129,310.77; and Glenside Avenue Park - \$69,580.04); and

NOW, THEREFORE IT IS HEREBY RESOLVED BY THE MEMBERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

1. The Authority hereby awards a contract to JCT Solutions under Union County COOP #8-2022 for Springfield Avenue Park - \$169,497.37; Green Lane Park - \$129,310.77; and Glenside Avenue Park - \$69,580.04 for a not to exceed contract of \$368,378.18.
2. The Authority hereby authorizes the Chairman or Executive Director to execute any purchase orders or documents that may be required to purchase the products from the System.
