RESOLUTION AUTHORIZING AN AMENDMENT TO THE PROFESSIONAL SERVICES CONTRACT AWARDED TO MAST CONSTRUCTION SERVICES, INC. FOR CONSTRUCTION MANAGEMENT SERVICES FOR THE UNION COUNTY GOVERNMENT COMPLEX

WHEREAS, pursuant to N.J.S.A. 40:37A-55(t), a County Improvement Authority is empowered to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the authority subject to the "Local Public Contracts Law," N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, on March 7, 2023, the Authority enacted Resolution No. 29-2023 and awarded a professional services contract to MAST Construction Services, Inc. for construction management services for the Union County Government Complex Project at a price not to exceed One Million Seven Hundred Twenty-Five Thousand Three Hundred Twenty-Five Dollars (\$1,725,325); and

WHEREAS, on September 9, 2025, the Authority enacted Resolution No. 63-2025 and authorizing additional funding to MAST Construction in the amount of Sixty Thousand Dollars (\$60,000) for additional schedule update reviews and accompanying documentation for a new contract value not to exceed One Million Seven Hundred Eighty-Five Thousand Three Hundred Five Dollars (\$1,785,325.00) ; and

WHEREAS, during the term of service a need for increased review and analysis of the Project Schedule and monthly schedule updates has arisen; and

WHEREAS, the Authority wishes to increase the contract with Mast Construction Services, Inc. in an amount not to exceed \$297,300 for project delays, claim preparation and anticipated additional support for a new contract value not to exceed Two Million Eighty-Two Thousand Six Hundred Twenty- Five Dollars (\$2,082,625.00); and

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE UNION COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

1. The Authority hereby authorizes an increase to the contract with Mast Construction Services, Inc. in an amount not to exceed \$297,000 for the additional schedule update reviews and accompanying documentation for a new contract value not to exceed Two Million Eighty-Two Thousand Six Hundred Twenty- Five Dollars (\$2,082,625.00).
2. The Authority authorizes the Chairman of the Authority to approve and execute any and all documents necessary to amend Mast Construction Services, Inc's contract. Such approval and execution by the Chairman shall be deemed approved by the Authority and no further action or approval is required.
