## **DEFILIPPO STATEMENT**

My job as Executive Director of the Union County Improvement Authority is one I value greatly. I have taken great pride in transforming an agency that was long dormant, jumpstarting it and completing \$330 million in projects that benefited the public and kept our economy vibrant.

In recent weeks, the Authority and I have come under an unwarranted series of criticisms that have threatened this progress and the agency's integrity. I am grateful that I was well paid by the agency I serve, as it takes into consideration my work product and my 34 years of government experience. I value my reputation, that of the Improvement Authority and all the projects we have completed through the years for various communities.

Candidly, for some time, I have been considering retirement, and after many years of public service, I believe the time is now appropriate for me to retire effective August 1st.

The work of the Improvement Authority is urgently needed—our children need schools and libraries, we need public safety buildings, and the unemployed and less unfortunate among us need institutions that provide a safety net, protect children from abuse, create employment opportunities and improve our quality of life. These projects have benefited tens of thousands and have been dear to my heart.

It is therefore equally important that the Improvement Authority no longer be subject to mistaken criticisms that can derail this progress for Union County.

As I look ahead, I believe there are other horizons, and challenges awaiting me.

Eighteen years ago I was elected as Union County Democratic Chairman. While Chairmen are never compensated financially, I have enjoyed my involvement in both my vocation, government and my avocation—politics. I have the greatest respect for the Democratic County Administration, which has accomplished so many great things for our residents.
